Kelli Jo Knapke, 49, Van Wert, charged with burglary, a felony of the fourth degree, not guilty plea, ordered held on a \$5,000 cash bond, case to be assigned by a visiting judge.

Amy McNabb, 37, Paulding, charged with possession of drugs, a felony of the fifth degree, not guilty plea, released on \$5,000 unsecured personal surety bond. A pretrial has been scheduled for July 28th, 2010 at 8:00 a.m..
