Driver cited for failure to yield

At 2:11 p.m. on Friday, a collision occurred when the driver of one vehicle failed to yield after stopping at an intersection.

Glenn Miller, 52, of Findlay, was headed westbound on West Fifth Street in the outside lane while Beverly Hickey, 79, of Delphos, was headed northbound on North Canal Street. Hickey came to a stop at the stop sign on Canal and proceeded through the intersection without seeing Miller's vehicle. Miller struck Hickey's vehicle in the right side, causing it to spin in a clockwise direction, coming to rest in the Subway parking lot.

There was possible injury to Miller, and moderate injury to Hickey, who was taken to St. Rita's by Delphos Fire.

There was disabling damage to both vehicles.

Hickey was cited for a failure to yield after stopping.
